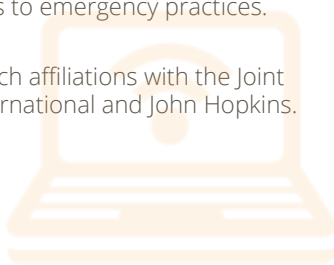
Overview of Process
